**DESCRIPTION: Stix® 2230** is a solvent-free adhesive with aggressive tack designed for the installation of vinyl-backed and non-vinyl-backed modular carpet tile, luxury vinyl tile (LVT), luxury vinyl plank (LVP), vinyl composition tile (VCT), vinyl sheet flooring, and fiberglass-reinforced vinyl sheet. **Stix® 2230** is also suitable for adhering most carpet cushions to substrate in a double-stick installation. **Stix® 2230** is non-staining and contains MicroSept® Antimicrobial System Protection to safeguard the adhesive against bacterial and fungal growth. When used with carpet tiles, this adhesive is formulated for releasing and re-bonding while permanently retaining its tack, allowing individual tiles to be lifted out easily and replaced without substantial loss of adhesive properties. When used with LVT, plank, and vinyl sheet flooring, **Stix® 2230** provides a tenacious, permanent bond. **Stix® 2230** is CRI™ Green Label Plus approved by The Carpet and Rug Institute for Indoor Air Quality, FloorScore® Certified by SCS Global Services for Indoor Air Quality, approved by The Resilient Floor Covering Institute (RFCI), and has a Silver Level MHC from the Cradle to Cradle Institute.

**BEFORE YOU BEGIN:** Important: Proper substrate preparations are essential. Moisture testing must be performed and documented before installation begins. Read XL Brands Technical Bulletin titled "Substrate Preparation" for complete instructions before beginning installation. **INSTALLATIONS:** Follow the flooring manufacturer's installation instructions and guidelines regarding adhesive application rate and method.

**INSTALLING CARPETTILE:** Spread the adhesive with an appropriate trowel or paint roller, and allow to dry completely before placing tiles for a releasable installation. Drying time is approximately 30 minutes, depending on ambient humidity and temperature. Be sure to install flooring during the working time of the adhesive, up to 4 hours after it dries completely.

**INSTALLING OVER NONPOROUS SUBSTRATES:** Install vinyl sheet, tiles, and plank flooring into adhesive as it becomes dry to the touch with little or no transfer to finger when touched. This will normally require 30–60 minutes of drying time at suggested installation temperature and humidity. Be sure to install flooring during the working time of the adhesive, up to 4 hours after it becomes dry to the touch. Do not install flooring into wet adhesive on nonporous substrates. Roll the installation in both directions with a 75–100 lb., 3-section roller immediately after flooring is placed, ensuring complete contact with adhesive.

**INSTALLING OVER POROUS SUBSTRATES:** Vinyl sheet flooring may be placed into adhesive after 10–20 minutes open time (flash-off) over a porous substrate. Be sure to install flooring during the working time of the adhesive, up to 4 hours after flashoff. When installing vinyl plank and tile over a porous substrate, the adhesive should be allowed to dry to the touch sufficient to prevent slippage. Loss of adhesion can result if the flooring is not installed within the working time of the adhesive. Roll the installation in both directions with a 75–100 lb., 3-section roller immediately after flooring is placed and positioned, ensuring complete contact with adhesive.

**TRAFFIC:** Follow the flooring manufacturer's installation guidelines; otherwise restrict foot traffic for 24 hours after installation. No heavy traffic, rolling loads, or furniture placement for 72 hours after installation.

Additional time may be necessary if the installation is over a nonporous substrate. Allow at least five days following the installation before conducting wet-cleaning procedures or initial maintenance.

**CLEANUP:** Use a clean, wet cloth to clean up adhesive while still wet. Dried adhesive may require the use of an appropriate solvent.
